

**2018 SNOWBALL
WAIVER OF LIABILITY AND INSURANCE FORM**

The undersigned hereby represents himself/herself and agrees to the following:

- I. That he/she is an experienced player of the game of rugby football and is familiar with the laws of the game.
- II. That he/she is aware that the game of rugby football is a contact sport in which participants expose themselves to the risk of bodily injury or death through their participation in the game.
- III. That he/she wishes to participate in the play of rugby football during the Snowball Rugby Tournament on February 17th, 2018.
- IV. That the undersigned hereby assumes all risks of damage or injury resulting from participation in the Snowball Rugby Tournament.
- V. That he/she agrees to waive any claim for damage, injury, or death arising out of this participation in Snowball Rugby Tournament against the; United States of America Rugby Football Union (USARFU), The Michigan Rugby Union, The Midwestern Rugby Union, the members of the Snowball Rugby Tournament Organizing Committee, the Kalamazoo Dogs Rugby Football Club Ltd., its officers, directors, members, and assignees, all tournament participants, sponsors, supporters and spectators, Kalamazoo Growlers Baseball Club, City of Kalamazoo Parks and Recreation and its affiliates.
- VI. That he/she agrees to indemnify and hold harmless the above-named parties in Section V, from any and all claims for damage or injury arising from his/her participation in the Snowball Rugby Tournament.
- VII. That the undersigned's signature on this document also indicates that he/she is completely knowledgeable concerning the Medical and Liability Insurance requirements of participants in USARFU events and will comply with those requirements. Further that he/she understands that the minimum of \$100,000 in medical insurance coverage is mandated to protect himself/herself and that the under signee holds harmless and indemnifies the Kalamazoo Dogs Rugby Football Club Ltd. and all of its officers, directors, members, and assigns, and any other groups associated with the Snowball Rugby Tournament.
- VIII. That his/her signature on the following page indicates that he/she does in fact have insurance coverage to meet this minimum \$100,000 medical insurance requirement set by the USA Rugby (USARFU).
- IX. That this waiver of liability also applies to any damages incurred to personal property while attending or participating in the Snowball Rugby Tournament.
- X. That the undersigned agrees to avoid damaging the property at the tournament location, except that normal damage which could be expected as a result of said Tournament, e.g. wearing down the turf.
- XI. That this waiver shall be binding upon the undersigned, his representatives, heirs and assigns forever.
- XII. That he/she is of legal age (18 years or older) to enter into this, a legal binding contract between players and the Kalamazoo Dogs Rugby Football Club Ltd.
- XIII. That he/she will follow the code of conduct outlined below:

Code of Conduct:

- 1st Offense - player/captain warning**
- 2nd Offense - player ejected from tournament**
- 3rd Offense - team ejection from tournament**

- Players will not drink or "tailgate" in the parking lot
- No GLASS containers are allowed
- No public Indecency: Outhouses must be used for all bathroom needs
- Any visually intoxicated person(s) (V.I.P) will be ejected from the tournament immediately
